Guarantee: Kismet Morgans guarantees to the mare owner a live foal for only two breeding seasons. After the second breeding, if the mare does not settle or have a live foal, this contract is null and void. A live foal is able to stand and nurse for 24 hours. In the event the foal dies within 24 hours, the stallion owner shall be notified within 3 days or the guarantee is null and void. A certificate or letter of death signed by a licensed veterinarian will be given the stallion owner within 10 days of the death of the foal. In the event of a return breeding, as a result of no foal, a substitute mare is allowed with the approval of the stallion owner.

Shipped Semen: Because 24-hour-notice to the Collection/Shipping center is required, please contact Mark Burke: (540) 460-7195 ahead of time so shipment can be arranged. We will confirm shipment. All semen that is shipped shall be tested and have a control sample maintained at Amethyst Acres Equine Center, Inc. The semen must be administered by a licensed veterinarian on the day of delivery and only to the contracted mare or the above guarantees do not apply. Orders are considered confirmed with 24 hours notice. If you need to cancel an order the mare owner will be liable for shipping charges if we have already processed the order.

Warranty: No warranties whatsoever, expressed or implied, shall accompany a breeding transferred by this agreement. No guarantee of delivery of shipped semen within a certain time period or guarantee that shipped semen will safely reach the insemination point or will be thawed without losing some integrity, quality or characteristics is given by this agreement.

When the mare owner(s) and stallion owner(s) sign this contract, it will be binding on both parties, subject to the above terms and conditions.
